From the Executive Director

At the Walters Art Museum, fiscal year 2021 (July 2020 to June 2021) was a year of evolution, as it was for so many museums across the country, challenging us to continue to expand our mission of connecting our community to our collection of seven millennia of art.


Through the strong guidance of our Board of Trustees and the dedicated work of our staff and volunteers, the Walters made significant progress towards our vision of being a force for transformation in our community as an anti-racist institution, a 21st-century museum, and an evolving civic organization that creates space for dialogue, reflection, and artistic creation.

Using the collections as a launchpad, we continued to expand our digital offerings during the COVID-19 pandemic, including scholarly talks and conversations with artists in the Baltimore community, art-making activities, and festivals like our annual Lunar New Year Celebration. We held the exhibitions *Translations and Transitions/Traducciones y Transiciones: A Celebration of Mexican and Central American Independence (1821–2021)*, *Building the Collection: 19th-Century European and American Art*, and partnered with the Baltimore Office of Promotion & the Arts on the annual *Janet and Walter Sondheim Artscape Prize Finalists Exhibition*.

The Walters Art Museum believes in the fundamental role art and history play in shaping a better future. We recognized how the history of racism in this country demands action from us as individuals and as a museum. In the wake of historic calls for justice and equality, we joined thousands of others in our city and around the world in affirming that Black Lives Matter and accelerating and embedding diversity, equity, access, and inclusion (DEAI) throughout the Walters' work and culture. We created a joint Staff & Board DEAI Working Group in conjunction with a standing Board DEAI Committee. These efforts produced our first set of institutional DEAI goals with immediate and multi-year initiatives to diversify and contextualize the stories the museum tells, create partnerships of trust, open dialogue, and accountability with our communities, and to support a Walters team culture based on clarity, inclusivity, and accountability.

Coinciding with these measures, we also released to the public an expanded institutional history, which begins the long and necessary work of acknowledging William and Henry Walters' support of the Confederacy, and how their original collections reflect the typical Eurocentric worldview that drove collecting at the turn of the 20th century in the United States and across Europe. This expanded history, written by a cross-section of Walters staff, was publicly shared in March 2021 and can be found on the museum website at <https://thewalters.org/about>.

As we continue to evolve as a museum, I want to express my gratitude for the ongoing support of everyone who visits the Walters virtually or in person. This report attests to the strong commitment of everyone who believes in our mission, enjoys participating in all that we have to offer, and works to ensure that the Walters Art Museum remains a vibrant and beloved part of the community for generations to come.

Exhibitions & Installations

New Acquisitions: Giovanni Boldini's *Lady with a Guitar*

August 15, 2018–February 27, 2022

In the last quarter of the 19th century, artists from Europe and the United States flocked to Paris, a remarkable hub of inspiration and creativity during the period. This installation highlighted the Walters Art Museum's most recent acquisition, *Lady with a Guitar* by Giovanni Boldini (1842–1931), which dates from that dynamic moment. Boldini, an Italian artist, arrived in Paris in 1871 and painted *Lady with a Guitar* early in his career, while he was exploring a variety of styles and subjects, drawing inspiration from his colleagues in Paris's vibrant artistic communities; many of these artists' works were displayed here.

Wealthy American collectors, such as William Walters and his son, Henry, the founder of the Walters Art Museum, also set their sights on Paris, enthusiastically purchasing works of art created there. Boldini regularly painted William and Henry Walters' contemporaries and friends, exhibited canvases in the same Parisian galleries that they frequented, and worked in a style that would have appealed to father and son. William Walters purchased Boldini's *In the Garden* (1874, now in a private collection) to display in his Baltimore home, and Henry Walters and his wife owned Boldini's *Young Woman Crocheting* (1875, now in the Clark), which hung in their Manhattan apartment.

Upon his death in 1931, Henry Walters gave 22,000 works of art to the City of Baltimore, transforming his private collection into a public museum. Through purchases and generous gifts, the Walters

has expanded its collection to nearly 36,000 art objects. *Lady with a Guitar* is the first work by Boldini in the museum's collection and allows us to draw new connections among the Walters' 19th-century artworks.

Excursions through the Collection: Portraiture, Adornment, and the Natural World

November 17, 2019–October 10, 2021

Excursions through the Collection brought together 35 masterpieces from across the Walters collections that express interest in three themes: portraiture, adornment, and the natural world.

Dating from the second century BCE to the early 20th century and representing cultures throughout the world, the works included a wide range of materials, from sandstone and gemstones to ivory and parchment.

These themes and more are featured in a new guide to art at the Walters—also named *Excursions through the Collection*—that was published in Spring 2020. The first of its kind in over 20 years, the guide highlights over 150 of the museum's star objects.

The St. Francis Missal

February 1–November 21, 2020

The St. Francis Missal—a legendary 12th-century manuscript and relic of touch of St. Francis of Assisi—had its first dedicated exhibition at the Walters Art Museum in 40 years.

The St. Francis Missal was an intimate exhibition that featured approximately 17 objects, including manuscripts, paintings, ivories, ceramics, and documentation of the Missal’s recent two-year conservation funded by the Mellon Foundation.

In 1208, St. Francis of Assisi and two followers were debating what God’s plan for them might be. Unable to agree, they sought answers at the church of San Nicolò in Assisi, where Francis often attended. They opened the Missal, which sat on the altar, three times at random and in every case, the text on the page urged renouncing earthly goods. This pivotal moment laid the foundation for the Franciscan order. Due to this possible contact with the saint, Franciscans worldwide consider the book now known as the St. Francis Missal to be a relic of touch, and many make pilgrimages to Baltimore to see it.

Decades of use took a toll on the book’s fragile binding, and in 2017, the Walters conservation staff began a two-year restoration project. The Missal has since been repaired and stabilized, and has been digitized for the Walters’ manuscript website *Ex Libris*.

The exhibition drew upon the Walters’ world-renowned rare books and manuscripts collection that spans more than 1,000 years and contains over 900 manuscripts, 1,300 of the earliest printed books, and 2,000 rare later editions from across the globe.

Building the Collection: 19th-Century European and American Art

September 7, 2020–February 27, 2022

Previously known as *From Rye to Raphael, Building the Collection: 19th-century European and American Art* was renamed to reflect a widened lens through which the Walters Art Museum’s collections and history are presented and were no longer primarily focused on the museum’s founders. The lobby included updated information about William and Henry Walters and their history supporting the Confederacy. The Walters is committed to making accessible the histories of its objects, its collections, and the institution, and we look forward to sharing our progress with you.

Today the Walters has over 36,000 works of art from cultures around the world, spanning seven millennia. The museum was formed from a gift by Henry Walters (1848–1931) of 22,000 works of art, two buildings, and an endowment to the city of Baltimore, “for the benefit of the public.” The foundational art collection was begun by Henry’s father, William T. Walters (1819–1894), and reflects these two men’s individual tastes and beliefs about what was culturally valuable and meaningful art. William and Henry Walters used their wealth, power, and social connections to collect art that reflected their 19th-century, Eurocentric worldview, which saw the height of human artistic production as a progression from Ancient Egypt, Greece, and Rome through the Italian Renaissance.

While the art William and Henry acquired is displayed throughout the museum, galleries on this floor told the story of how some of it was collected. The galleries displayed European and American art purchased by the Walters and contemporary to their lifetimes, as well as Asian art they bought at World’s Fairs. Importantly, some works that were on view here were acquired by the museum since it opened in 1934 with the aim of filling gaps in the founders’ collecting, such as works by artists of color.

Recent Acquisitions: Expanding the Collection

March 17, 2021–February 27, 2022

An 18th-century painting of an Incan king with a Peruvian saint, a contemporary vase featuring Frederick Douglass, teacups painted with images of Kabuki actors, and a 16th-century book depicting the Sami peoples of Scandinavia connected in this exhibition to tell the story of the Walters' expanding collection. This intimate display of 14 recently acquired works represented 700 years of history and featured books, paintings, sculptures, and ceramics. *Expanding the Collection* spoke to the new stories and perspectives these works bring to the Walters and included insights from curators who helped acquire them.

Translations and Transitions / Traducciones y Transiciones: A Celebration of Mexican and Central American Independence (1821–2021)

March 17–November 7, 2021

The Walters Art Museum commemorated Mexican and Central American independence from Spain with this exhibition exploring the cultural exchange between Indigenous and European peoples. Focusing on the many vibrant and sophisticated Indigenous societies that flourished over thousands of years in what is today Mexico and Central America, this small but rich exhibition featured 17 works of art including books, gold adornments, and ceramic vessels. It also featured an original painting by Mexican-American artist René Treviño, which seeks to reclaim Indigenous astronomical knowledge through a creative reimagining of 16th-century European star charts.

The Janet and Walter Sondheim Artscape Prize Finalists Exhibition 2021

May 27–July 18, 2021

The 2021 Janet and Walter Sondheim Artscape Prize, which awarded a \$25,000 fellowship to assist in furthering the career of a visual artist or visual artist collaborators living and working in the greater Baltimore region, opened Thursday, May 27, with a finalists exhibition. The 2021 Sondheim exhibition was a hybrid event that featured the work of five finalists displayed in the first-floor exhibition galleries and a virtual award ceremony.

The five individual artists selected as 2021 finalists were Hoesy Corona, Tsedaye Makonnen, Jonathan Monaghan, Lavar Munroe, and Hae Won Sohn. Their work was on view Thursday, May 27, through Sunday, July 18, 2021. The winner of the 2021 Sondheim Artscape Prize was announced during a special award ceremony on Saturday, July 10, 2021. Additionally, works by semifinalists not moving to the finals were selected by Baltimore Office of Promotion and the Arts (BOPA) curator Lou Joseph for a separate exhibition during the summer of 2021. The 2021 jurors were Naz Cuguoglu, Michelle Grabner, and Meleko Mokgosi.

Named in honor of the philanthropists and civic leaders Janet and Walter Sondheim, the Sondheim exhibition is co-organized by BOPA, which serves as the city's arts council, events producer, and film office in addition to organizing free city-wide events. The Sondheim exhibition brings together artists from disciplines including painting, photography, sculpture, animation, and fiber craft.

The exhibition at the Walters Art Museum was made possible through the combined generosity of individual donors, foundations, corporations, and grants from the City of Baltimore, Maryland State Arts Council, Citizens of Baltimore County, and Howard County Government and Howard County Arts Council.

The Women’s Committee of the Walters Art Museum

The Women’s Committee of the Walters Art Museum was established by the Board of Trustees of the Walters Art Museum, Inc. in 1963 with a mission to support and promote the Walters. Beginning with 12 determined members, the Committee grew to nearly 100 members at its peak.

Over the last 58 years, the Women’s Committee created goodwill for the museum and supported programs and projects that inspired creativity, learning, and exploration for students and families, and engagement for thousands of museum visitors, both onsite and online. Contributing gifts in excess of \$2 million to the Walters, the Women’s Committee raised funds to support the museum’s general operating costs, including bus transportation for over 75,000 Baltimore City school children visiting the museum; 25 special exhibitions; eight Summer Camp scholarships; and two family festivals. In 2021, the Women’s Committee supported new educational resources including Classroom Connect and the distribution of 10,000 Art Kits to Baltimore City and Baltimore County families.

Effective June 30, 2021, the Women’s Committee established the Walters Women’s Committee Legacy Endowment to support the efforts of the museum in perpetuity and ceased operations as an active committee. Funds from the Endowment continue the legacy of the Women’s Committee and their longstanding commitment to support educational programming and expenses related to special exhibitions at the Walters.

The museum would like to recognize and honor the 12 founding members of the Women’s Committee of the Walters Art Museum and to commend them for their foresight and perseverance in creating a group of individuals who will forever remain synonymous with the Walters.
